16. In case of any disputes, it will be resolved within the jurisdiction of Tripura High Court only.

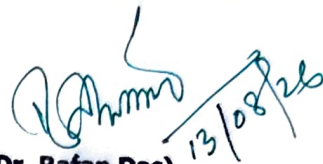
